The program is comprised of three (3) separate lines of research: Cancer, Mitochondrial mutations, and Lysosomal storage. A new, internal Lysosomal project was brought in-house during the final quarter of 2015. The Cancer line of research has made significant research associations with other researchers in the field and is working toward publication and a patent application. The Mitochondrial mutations line of research has completed proof of concept and is moving ahead with their work, presenting their findings at conferences internationally.

4b (Code: ) (Expenses \$ 657,635. including grants of \$ 647,385. ) (Revenue \$ ) Extramural Research - the extramural research program funds some of the most prestigious institutions around the world. Many of our extramural projects this year attained extensions to their original grants due to progress in their research. A couple programs completed their studies and have been discontinued. Funding for this program continues to be prioritized for projects that meet our company mission and are currently being unaddressed in our intramural research program.
